INSTRUCTING MORE THAN 353 PARENTS OF YOUNG CHILDREN IN 4 SCHOOL DISTRICTS AND HEAD START, THE PROGRAM RECOGNIZES THAT THE WHOLE FAMILY BENEFITS WHEN PARENTS STRENGTHEN THEIR LITERACY SKILLS. IN 2023, THE LITERACY CENTER'S PROGRAM WAS SELECTED AS ONE OF THREE PARTNERS IN A NATIONAL COHORT OF HIGH PERFORMING FAMILY LEARNING SYSTEMS.
